

Dean's Directive No. 5/2024

Provision for the Possibility to Continue Studies in an Identical or Similar Programme of Study

In connection with Rector's Directive No. 9/2024 Details on Provision for the Possibility to Continue Studies in an Identical or Similar Programme of Study in Case of Termination of Accreditation and Right to Offer a Programme of Study under Institutional Accreditation, I issue the following Dean's Directive:

Article 1: Subject Matter of the Directive

- 1. This Directive regulates the details and organizational aspects involved in ensuring that students have the possibility to continue studying in an identical or similar programme of study at the Faculty in case the accreditation of the following programmes of study is terminated:
- a) Bachelor's programmes of study:
 - Protestant Theology, field of study: Theology of Christian Traditions full-time study; and
 - Social Work, field of study: Social and Pastoral Work or Pastoral and Social Work full and part-time study;
- b) Post-bachelor programmes of study (master's programmes of study which are a continuation of bachelor's programmes):
 - Protestant Theology, field of study: Protestant Theology full and part-time study; and
 - Protestant Theology, field of study: Christian / Community Crisis and Pastoral Work Diaconia – full and part-time study.
- 2. The programmes of study are specified and implemented by curricula.
- 3. The purpose of completion-of-study curricula is to allow students to complete their studies in newly accredited programmes of study without major changes.

Article 2: Successor Programmes of Study

The Internal Evaluation Board of Charles University determined the following successor programmes of study:
