How to compose an Individual Study Plan (ISP) for doctoral studies at the Protestant Theological Faculty of the Charles Univesity in Prague


The basis of doctoral studies at ETF UK is an individual curriculum, called the *Individual Study Plan* (ISP). A doctoral student composes this curriculum together with his/her supervisor. Having done so, the plan has be inserted into the *Student Information System* (SIS) of the Charles University (https://is.cuni.cz/studium/).



To do so, you have to login first and then open your Individual study plan:



Having done so, open your ISP proposal by clicking on the icon of a sheet:





This will open your personal card. Here you can find several fields under the header with your

name, supervisor's name, etc. You will skip the History of statements and reasons for returning the individual study plan and click on the box:


1. Dissertation and progress on the dissertation

Here You click on the *progress on the doctoral dissertation*. In four paragraphs, you describe briefly the expected course of your dissertation. You need to find a compromise between specificity, which might limit you later, and vagueness, which would say nothing about



your project. The whole plan must be designed so that the dissertation manuscript is completed by the

fourth year of your doctoral study. It might look like this (for inspiration, not for copying):



2. Course of study

This is followed by the Course of Study, in which you briefly describe your study plan by years (except for your work on the dissertation, which you have already described above). It might look like this:

Course of study

Year 1: Participation in the Old Testament PhD Seminar; participation in a two-semester course in Coptic, concluding with a PhD examination. Particular doctoral exam in systematic theology. As assigned by the supervisor, two sub-papers on the dissertation topic.


Year 2: Attendance at the New Testament seminar. Study of French, concluded by a particular doctoral examination. The completion of a seminar in the New Testament followed by a particular doctoral examination in the NT. A paper assigned by the supervisor will be the basis of a paper presented at a doctoral conference and, after necessary revisions, submitted by the end of September for publication in the journal Theological Reflection.

Year 3: Participation in the PhD seminar in Religious Studies and a particular PhD examination at the end of the year. Following an active participation in an international conference (tentatively EABS in Berlin in April), a two-week study stay in Berlin is planned. The conference paper will be revised and submitted for publication.

4th year of study: an internship at the VU in Amsterdam is planned for the beginning if this year. In addition to work on the dissertation, participation in a seminar for PhD students is expected, folloed by an active participation in the International Colloquium Biblicum in Prague, when I return from Amsterdam. Publication of the central thesis of the dissertation in a professional journal. State doctoral examination in the spring, thesis defence at the end of the year.

3. List of duties


This rather loosely written individual curriculum must be projected into the following list of duties. The list represents a hard, auditable part of your ISP, you must "translate" your curriculum into particular courses (which include seminars and all exams), publications, conferences, international internships, and other things (e.g., papers, provided your supervisor suggests you to do so). You can add these duties by clicking on the "add" button. Your duties should be assigned for one of the four years of your curriculum. In case of seminars, classes, examinations and papers, the duties have to be inserted with their particular codes (see the list bellow) or the icon



3.1.3 Particular exams in doctoral studies:

during the course of his/her studies, the doctoral student must pass three particular doctoral exams in theological disciplines (or philosophical ones in case of the programme *Philosophy of* Religion). He/she chooses it from the following nine disciplines with regard to the focus of her dissertation project (the discipline of the dissertation is excluded because it will be examined as



of study (note the codes for exams below).

the final *State Doctoral Examination*, se bellow): Exam in the Old Testament; Exam in the New Testament; Exam in Church History; Exam in Systematic Theology; Exam in Theological Ethics; Exam in Practical Theology; Exam in Religious Studies; Exam in Philosophy; Exam in Ecumenical Theology. If required by the dissertation theme, one of the three particular exams may be taken from a discipline other then those listed above. These particular exams should be completed within the first three years

- **3.1.4 A language examination** in a second foreign language is compulsory. In addition, PhD students in Biblical Theology are usually required to take an exam in one of the other ancient languages, e.g. Aramaic, Akkadian, Syriac, Coptic, etc. (note the codes for foreign language exams below).
- 3.1.5 Once you have fulfilled all the requirements of your doctoral studies, you may take the State Doctoral Examination in the subject area of your dissertation project (note this in the Subject Code below).
- 3.1.6 Doctoral studies are successfully concluded with **the defence of the dissertation**. Register it in Your ISP as a course with the code RDZ09.

3.2. Publications

The PhD student is required to publish at least one scientific study in a world language and at least two scientific articles in the language of instruction; at least one of these articles must be published in an international indexed scientific journal. The publication obligation is fulfilled only if the text is registered in OBD, the bibliographic database used by Charles University.

3.3 Internships

A granted part of the doctoral studies is an internship abroad, which can be done either once or more than once. The total length of all internships should be no less than three months.

3.4 Other

Depending on the nature of the dissertation project, the doctoral studies usually include the preparation of "papers", usually on specific topics of the dissertation project. At the time of formulating the plan, the topic of the papers may not yet be clear, but if they are envisaged, they should be registered in the plan (e.g. one or two per year).

3.5 Conference

It is a standard for doctoral studies to take active part in at least one professional conference, preferably international (in a foreign country or at least with foreign participants and in a foreign language).

The completed plan is to be forwarded by the student to the supervisor (press "Student action: forward the plan to the supervisor").

2.1.1 At least **4 doctoral seminars** have to be taken during the course of study, usually in the field of the dissertation project. If later a seminar does not take place in a given year, the subjectarea board will determine which seminar replaces it.

In the doctoral programmes *Biblical Theology*, *Historical and Systematic Theology and Practical and Ecumenical Theology* and *Theological Ethics*, it is possible to take one of three *Partial doctoral examinations* in a field other than the traditional theological disciplines (designated by codes RDP01 to RDP085 here); this may be an Partial doctoral exam taken at the faculty or at another academic institution; in this case, code RDP11 is used and the discipline of the examination is specified. In the degree programme *Philosophy of Religion*, the 3 Partial examinations consist of 'Philosophical or Theological Disciplines'; unless it is one of the traditional theological disciplines, the ISP will use codes RDP11 to RDP13 and the discipline of the examination will be specified.
