**AGREEMENT ON EDUCATIONAL COOPERATION
BETWEEN
PROTESTANT THEOLOGICAL FACULTY OF CHARLES UNIVERSITY
AND
GRADUATE SCHOOL OF CHRISTIAN STUDIES OF RIKKYO UNIVERSITY**

This memorandum of understanding and agreement is entered into between Protestant Theological Faculty of Charles University (hereinafter referred to as PTFCU) and Graduate School of Christian Studies of Rikkyo University (hereinafter referred to as GSCSRU) for the purpose of seeking possibilities to enhance mutual academic exchanges and to maintain close relationships between the two institutions.

1. Both parties agree to cooperate in exchange of scholarship plans of mutual interest. Details of the arrangements will be discussed in future deliberations.
2. Both parties agree to pursue faculty and student exchange programs, terms to be discussed at a later date and on a case-by-case basis.
3. Both parties agree to seek exchanges to cultural and artistic activities.
4. Both parties agree to collaborate on cooperative research and hold joint academic seminars where appropriate.
5. Both parties agree to cooperate in advanced studies or research and education of graduate students.

Through the execution of this agreement, both parties are agreeing to seek ways to implement the above stated areas of cooperation and to create enhanced educational value.

This agreement shall not be construed as indicating or inferring the transfer, assignment or infringement of any intellectual property rights between the two institutions.

Every specific activity implemented within this framework will require a separate written agreement, signed by both parties, which will specify the sources of finance, intellectual property, and insurance issues.

This agreement will be valid for five (5) years from the date of signing it. This agreement shall be renewed automatically for succeeding terms of five (5) years unless either party gives written notice to the other at least four (4) months prior to the expiration of the agreement.

The foregoing agreement between PTFCU and GSCSRU, having been duly approved by both parties, is hereby executed by the undersigned authorized representative(s) of each party.
